Dan questioned why there was \$16,000 budgeted as expenditures for “Discount Tickets” and only \$15,000 budgeted as revenue. Debra felt this could be an error. There was some revenue from this program. Debra stated that we do prepay for tickets purchased from Frank Theaters. Debra stated that we do not always receive the commission check from PRPS until the following year, so there is actually more income than what is indicated from actual monies received.

Summer Playground – Debra and Monica discussed expanding the program to five full days a week for 2011. She suggested a cost of sixty dollars a week for residents and sixty five dollars a week for non-residents. After some discussion, the Board felt this was acceptable.

Board Vacancy – Debra has not received any applications for the Board vacancy.

Red Lion Senior Center – The Red Lion Senior Center has requested some help with some of the trips that they do. We will also allow them to advertise on our website.

Lacrosse Tournament – This was a tournament that was held last year. We still have not been paid for the use of the fields. He owes us \$600. Debra will continue to pursue this.
