Fireworks – There will be a fireworks show on Friday, July 1. We will possibly do fireworks and a movie. We need to look at finding some additional parking.

Bridgewater Recreation Fees – See proposal by Monica Love. Dan questioned how this would affect us if the trails were constructed after we received the money. Debra will check into this further.

2011 Capital Projects Update – Debra asked if she could use money to do brochures for the Ma & Pa Community Greenway. Joseph made a motion to approve money for the brochures. Dan seconded. All approved. The Board recommended that Debra stay on the project committee.
